COURSE DESCRIPTION -

International Students must have a good command of written and spoken English International students who do not have English as first language will need to show that they are capable of completing the course successfully by meeting at least one of the following entry requirements:

An IELTS score (Academic Module) of 6.0 with no individual band score less than 5.0, or Certificate IV or Higher of AQF qualification or

PTE, with the minimum of overall 43 score (at least 36 score in each module)

Students with 5.0 bands will be considered if they have completed ELICOS program for minimum of 10 weeks.
